NOTICE OF REGULAR MEETING

The Board of Directors of Cameron County Drainage District No. 5 will meet in regular session at 221 East Van Buren Ave., Suite 4, Harlingen, Texas, on Tuesday, June 11, 2024, at 8:00 A.M. to consider the following business.

1. Pledge of Allegiance
2. Minutes. Read Minutes of May 30, 2024 Meeting make any corrections, and approval.
3. Introduction of guests / Public Comment Period.

The Public Comment portion of the meeting promotes a fair and open process for the governance of the District. This portion of the meeting is not intended to be an extended discussion or a debate and is limited to three minutes for each presenter and the total public comment shall be limited to 30 minutes. Due to the provisions of Texas Open Meetings Act, the Board Members do not reply; they listen. Matters under litigation are not to be addressed and comments regarding specific District employees and elected officials may be prohibited. If you are discussing something not included on the agenda, the Board of Directors cannot take any formal action until it is placed on an agenda and notice of the meeting is properly posted. Registration for Public Comments must be submitted to the District Secretary before the meeting is called to order. As the Board President calls upon those who submitted a registration form with the District Secretary, please step forward and state your name and address before beginning your presentation.

4. Subdivisions. Consider and take action on the following:

4.1 THE PARK AT ROOSEVELT SUBDIVISION PHASE I – BEING 7.28 ACRES OF LAND OUT OF A 19.16 ACRE TRACT CONVEYED TO THE DEVELOPMENT CORPORATION OF HARLINGEN, INC, BEING OUT OF LOT 3, F.Z. BISHOP SUBDIVISION.

5. City of Primera Request.
Consideration and action to consider request by the City of Primera to excavate and to maintain the 5 acres of land east of Richmond Hills Subdivision as a detention pond.
6. Deliberations about Real Property–Combes Relief Drain Project. Recess open meeting and conduct a closed meeting pursuant to Government Code Section 551.072 to deliberate the purchase and value of a tract of land in Sections 22 and 23 of the Cameron County School Lands, if the Board determines that deliberation in an open meeting would have a detrimental effect on the position of the District in negotiations with the landowner. If Board does not conduct a closed meeting, go to agenda item 7. If the Board conducts a closed meeting, go to agenda item 7 when the Board reconvenes in open session.

7. Combes Relief Drain Project--Purchase of Real Property in Sections 22 and 23 of the Cameron County School Lands. Consider, make decisions, and take action on purchase of land in Sections 22 and 23 of the Cameron County School Lands.
8. Deliberations about Real Property– Murphy-Southfork Laterals Interconnect Project. Recess open meeting and conduct a closed meeting pursuant to Government Code Section 551.072 to deliberate the purchase and value of a tract of land in Block 39, Wilson Tract Subdivision if the Board determines that deliberation in an open meeting would have a detrimental effect on the position of the District in negotiations with the landowner. If Board does not conduct a closed meeting, go to agenda item 9. If the Board conducts a closed meeting, go to agenda item 9 when the Board reconvenes in open session.
9. Murphy-Southfork Laterals Interconnect Project--Purchase of Real Property in Block 39, Wilson Tract Subdivision. Consider, make decisions, and take action on purchase of land in Block 39, Wilson Tract.
10. Consider and take action on engaging surveyor. If necessary, discuss with attorney in executive session.
