**Corsif Acres Subdivision** – Being 3.73 acres of land out of Block Number Two (2), F.Z. Bishop Subdivision of Section No. 39.


**Bothwell Heights Subdivision** – Being 0.891 of one acre out of Block 21, Howards Dixieland Heights.
