- Item 2 After discussion, motion was made by Jerome Wade seconded by Nicholas Consiglio and passed, that the **Minutes of the Regular Meeting of September 26, 2023**, be approved.

- Item 4 After discussion, the following action was taken on subdivision plats:

Caliber Collision Harlingen (A SUBDIVISION OF 8.0107 ACRES BEING A REPLAT OF A PORTION OF BLOCK 11 STUART PLACE SUBDIVISION) – Motion was made by Jerome Wade, seconded by Nicholas Consiglio and passed to approve the preliminary plat. The original was not present.

Blackjack Subdivision (3.17 ACRES OF LAND OUT OF LOT 2 & LOT 3, BLOCK 16, THOMPSON SUBDIVISION) - Motion was made by Nicholas Consiglio, seconded by Jerome Wade and passed to approve the preliminary plat. This subdivision is adjacent to District drain. A license agreement is required to discharge into drain.
